New Roof for the Marcus Isbister Old School and Denman's Bats

Work on the roof-repair-project for the Old School will soon begin! Most of our bats are currently away hibernating. They often go far from Denman, but hopefully will be returning with the warm weather. Meanwhile, the Conservancy and the Old School Committee will do our best to ensure that the very significant maternal colony of bats will continue to have access to the Old School's attic in the summer to birth and raise their young.

The Old School's roof covers a large attic area that for many decades of summers has provided critical maternal habitat for several important species of bats. Some of our 1000 bats may live as long as 40+ years, so they've been here awhile! They probably know Central Park, the Old School

area and their neighbours very well. They also help us out. One of our bat species, the now rare little brown bat, has been shown to consume as many as 600 mosquitoes in one hour. Thus all around the Old School area, these bats are foraging nightly for their weight in bugs, and are certainly helping both gardeners and all those enjoying the out of doors.

The Conservancy has several bat-attic projects proposed for the Old School. Our first, is flooring the attic before the bats return, to help to keep their area separate from that of the humans. If you have an interest in saving our bats, the Conservancy would welcome any donations (tax deductible) to help with this and our other bat projects. As well, we sincerely would welcome the help of any builders, interested in bats, who are willing to assist in putting plywood down over the attic floor joists. Special Resolution: membership



- define when members are/are not in good standing and when a person ceases to be a member.

Taylor's Checkerspot Butterflies and the DCA - UpDate

As many of you know, Denman Island is home to the only known breeding populations of the Taylor's checkerspot (*Euphydryas editha taylori*) butterfly in Canada. Populations of the butterfly have been declining in size since 2008 and very few larvae or adults were observed last year. In 2013, the DCA applied for a one year federal grant under the HSP program of the Ministry of the Environment to develop and implement conservation measures for the butterfly on DCA and other private lands. DCA was informed in the summer that it had not been awarded the grant. However, at the end of the year, we were told that some money was available and asked if could the DCA carry the program out by the end of March (yikes!)? Naturally, DCA did not turn the money down and frantic work will ensue! This will include management plans for Taylor's checkerspots on two small areas on DCA properties and another private property. In addition a manual of land management for the long-term survival of the butterfly will be compiled. The DCA work will be coordinated with work carried out by the Taylor's checkerspot Working Group and BC Parks in the new provincial park in the northern part of the island.

Margaret Ida Pauline Sizmann
October 11, 1920-October 21, 2012

Long time Denman resident Margaret Sizmann was writing her will. She knew that she had only a short time left to live but she had no heirs to leave her estate to.

Margaret was born Margaret Thomson in Riga, Latvia. Margaret came to Canada by ocean liner in 1953 with her husband, a Mr. Sizmann. The marriage ended and Margaret, always a fiercely independent lady, went to work as a seamstress and then found long-term employment with an engineering firm becoming a draftsman and designer of pipes for pulp mills. She lived in West Vancouver in those days.

Margaret became a resident of Denman in 1980. She was an avid gardener and participated in one of the early Home and Garden Tours. She enjoyed traveling in her camper van, on her own, usually taking a dog or two with her, and going as far south as the Baja peninsula.


Margaret had always been concerned about the welfare of animals. She had her estate divided between five charities: 2 charities focused on animal welfare, the Red Cross, the Georgia Strait Alliance, and the Denman Conservancy Association. Margaret wanted her bequest to DCA to be used for animal habitat. She told a friend before she died, "you tell them that this isn't for lawyers and accountants. This is for animal habitat!"

Margaret's is the second large bequest left to DCA. In 2005 DCA received a large sum from a generous off-island donor. That money was used for DCA's Central Park property. Margaret's generous bequest will be added to DCA's restricted fund for acquisitions.

The DCA appreciated Margaret's commitment and support for our stewardship program in the 1990's. Her recent bequest continues her legacy!

project. This trip is part of an eight week program with the overall goals to:


- create greater awareness and understanding of the marine life system;

Peter's "Marine Life 2014" project opened with a lecture by John Tayless about marine biodiversity, followed by the presentation at the Field Station.



Next will be a visit to a working shellfish tenure, a mini beach cleanup, class room experiments mimicking harvesting of geoducks and ending with a show and tell with an invitation to Islanders to see what the students have learned an accomplished.

Spartina densiflora Invasive Marine Grass – Update

On January 30th Dan Buffett, the Conservation Program Coordinator for Ducks Unlimited and Chair of the BC Spartina Working Group conducted a workshop on Denman about our invasive marine grass, Dense flower Cordgrass or *Spartina densiflora*. Dan reviewed how the *Spartina* species

have spread all along the western North American coastline. He also showed the ecosystem damage

that resulted as the *Spartina* replaced the existing mudflat habitat. Dan concluded with how the collaborative international *Spartina* control program has been very effectively removing this grass. So far, the Denman *Spartina* Project has removed almost 8000kg of plant material or almost half of the plants from Denman's shoreline. Plans are to remove the remainder this spring. Reports detailing the Denman and Vancouver Island *Spartina* 2013 work will be placed in the Denman Library.
